4 **WHEREAS,** the Tohono O'Odham Nation has recognized the importance of Head
5 Start Education and stimulation; and

7 **WHEREAS,** the Tohono O'Odham Nation has operated a Head Start Program
8 to provide and serve educational and pre-school learning
9 experiences for children between the ages of 3-5 years of age; and

11 **WHEREAS,** the Department of Health and Human Services, Administration for
12 Children, Youth and Families, has provided funding for the
13 operation of the Head Start Program; and

16 **WHEREAS,** the Administration for Children, Youth and Families will provide
17 funds for the continued operation of the Head Start Program to
18 legal and qualifying applicants; and

21 **WHEREAS,** the Tohono O'Odham Legislative Council has reviewed and
22 approved the Head Start Grant Proposal.

24 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'Odham Legislative
25 Council that it does authorize and request the Department of
26 Health and Human Services to contract with the Tohono O'Odham
27 Nation for the provision of services titled: Head Start Program.

3 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council that the

5 **Tohono O'Odham Nation will not fund or operate the program in**

7 **the interim while negotiations are still being conducted and no**
8 **executed grant has been approved by the Department of Health**
9 **and Human Services, Administration for Child, Youth and Families.**

11 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council that the
12
13 **Tohono O'Odham Nation's Officials, to wit: the Chairman and any**
14 **designated officials are hereby authorized to negotiate and execute**
15 **the grant, provided however, that any amendments affecting the**
16 **funding or funding levels of this grant shall be submitted for**
17 **further prior approval by this Council.**

21 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council**
22 **on the 25TH day of SEPTEMBER, 1995 at a meeting at which a quorum was**
23 **present with a vote of 1,734.0 FOR; -0- AGAINST; -0- NOT VOTING; and 142.0**
24 **[08] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of**
25 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
27 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
28 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
