**WHEREAS, the Tohono O'odham Legislative Council has been informed of the**  
**Indian Oasis Inter-Tribal Dance Group's interest to travel to Hawaii**  
**on October 4 - 10, 1995; and**

**WHEREAS, this group has performed in various events throughout Arizona and**  
**abroad in past years; and**

**WHEREAS, the parents and sponsors have raised \$5,000 thusfar to support this**  
**particular trip.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**  
**that it does hereby support and authorizes \$4,872.48 for the Inter-**  
**Tribal Dance group to travel to Honolulu, Hawaii on October 4 -**  
**10, 1995.**

**The foregoing Resolution was passed by the Tohono O'Odham Council on the**  
**25TH. day of SEPTEMBER, 1995 at a meeting at which a quorum was present**  
**with a vote of 1,123.5 FOR; 565.5 AGAINST; 187.0 NOT VOTING; and [08]**  
**ABSENT, pursuant to the powers vested in the Council by Section 3 of Article II**  
**and Article VI Section 1(d) of the Constitution of the Tohono O'Odham Nation,**  
**adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by**  
**the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**  
**1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
