4 **WHEREAS,** by Resolution No. 94-446, the Tohono O'Odham Legislative

6 Council approved a consultant contract with Graciela Barajas  
7  
8 Robinson for translating and interpretive services to the Nation  
9  
10 on issues affecting the Nation's interests in the Pinacate and Gran  
11  
12 Desierto del Altar Biosphere Reserve in Sonora, Mexico and the  
13  
14 Upper Gulf of California; and

16 **WHEREAS,** the Tohono O'Odham Nation's fiscal year ends on September 30,  
17  
18 1995 for FY 1995; and

20 **WHEREAS,** continued participation of the Nation in the management of the  
21  
22 Pinacates is required to protect the Nation's interests.

24 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'Odham Legislative  
25  
26 Council that it hereby authorizes the continuation of the contract  
27  
28 with Graciela Barajas Robinson at current spending levels in  
order that services will not be interrupted.

**BE IT FURTHER RESOLVED** that this continuing Resolution shall expire on  
October 31, 1995.


