4 **WHEREAS,** by Resolution No. 94-446, the Tohono O'Odham Legislative Council  
5  
6 approved a consultant contract with Graciela Barajas Robinson for  
7  
8 translating and interpretive services to the Nation on issues  
9  
10 affecting the Nation's interests in the Pinacate and Gran Desierto  
11  
12 del Altar Biosphere Reserve in Sonora, Mexico and the Upper Gulf  
13  
14 of California (hereinafter referred to as the "Pinacates"); and

15 **WHEREAS,** the budget of \$18,000., is not sufficient for the consultant to  
16  
17 complete her work under the contract; and

18 **WHEREAS,** continued participation of the Nation in the management of the  
19  
20 Pinacates is required to protect the Nation's interests; and

21 **WHEREAS,** the Cultural Preservation Committee recommends approval of  
22  
23 Amendment No. 1 to the consultant contract with Graciela Barajas  
24  
25 Robinson for fiscal year 1995 to increase the budget by \$5,400.,  
26  
27 consisting of \$4,500., for fees and \$900., for expenses.

28 **NOW, THEREFORE, BE IT RESOLVED THAT:**

1. The Tohono O'Odham Legislative Council hereby approves

Amendment No. 1 to the consultant contract with Graciela Barajas Robinson which increases the consultant's budget by \$5,400., for the fiscal year ending September 30, 1995.

2. The Legislative Council appropriates the sum of \$5,400., from the general revenue account to pay the additional fees and expenses under Amendment No. 1 to the consultant contract.
3. The Chairman of the Nation, the Chairman of the Legislative Council, and the Chairman of the Cultural Preservation Committee are authorized and directed to execute Amendment No. 1 to the consultant contract.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 25TH day of SEPTEMBER, 1995 at a meeting at which a quorum was present with a vote of 1,674.5 FOR; 134.0 AGAINST; 67.5 NOT VOTING; and 08 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
