RESOLUTION NO. 95-471

WHEREAS, the Department of Human Services submits its proposal to contract for the Sells Service Unit - Security Guard Services under a 638 Self Determination Contract with Indian Health Services

WHEREAS, the Tohono O'Odham Department of Human Services recognizes the continued need for hospital security services and;

WHEREAS, the Tohono O'Odham Nation does desire to contract for provisions of services for FY 1996; and

WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approved the Security Guard Direct Program and Contract Support/Start Up Budget Proposal for FY 1996.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does authorize and request the Public Health, Indian Service to contract with the Tohono O'Odham Nation under P. L. 93-638.

BE IT FURTHER RESOLVED that the duration of this contract is October 1, 1995 through September 30, 1996.

Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice
Chairman and any designated official are hereby authorized to
negotiate and execute the contract, provided however, that any
amendments affecting the funding or funding levels of this contract
shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council
on the 27TH day of SEPTEMBER, 1995 at a meeting at which a quorum was
present with a vote of 1,375.0 FOR; -0- AGAINST; -0- NOT VOTING; and 501.0
[10] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of
Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
