(Approving San Lucy District to Continue Operations under FY95 Budget)**

**RESOLUTION NO. 95-473**

**WHEREAS, the San Lucy District is currently in the process of reviewing their financial needs of the District for Fiscal Year 1996; and**

**WHEREAS, the District Council intends to have San Lucy District FY 1996 Budget for review and approval process completed as soon as possible; and**

**WHEREAS, the San Lucy District Council is asking for approval of Continued Operations under FY95 Budget, pending approval of the FY 1996 Budget by the District Council and Legislative body; and**

**WHEREAS, it is in the best interest of the San Lucy District that existing authorization be continued until such time that the Legislative Council conducts a thorough review of the budget and approves the same.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it does hereby authorize the San Lucy District to continue their current operations until their FY96 Budget is approved.**


