## NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'Odham Legislative Council hereby approves a consultant contract with Graciela Barajas Robinson in the amount of \$35,000., for the fiscal year ending September 30, 1996 in the form attached hereto.
- 2. The Legislative Council hereby appropriates the sum of \$35,000., from the General Revenue Account, to pay the fees and expenses under the consultant contract.
