4 **WHEREAS,** by Resolution No. 94-446, the Tohono O'Odham Legislative Council
5 approved a consultant contract with Graciela Barajas Robinson for
6 translating and interpretive services to the Nation on issues affecting
7 the Nation's interests in the Pinacate and Gran Desierto del Altar
8 Biosphere Reserve in Sonora, Mexico and the Upper Gulf of
9 California (hereinafter referred to as the "Pinacates"); and

13 **WHEREAS,** the consultant contract was amended by Resolution No. 95-464 to
14 increase the budget by \$5,400.; and

16 **WHEREAS,** the consultant contract expired on September 30, 1995; and

18 **WHEREAS,** the Cultural Preservation Committee has added additional duties to
19 the consultant contract for Graciela Barajas Robinson for Fiscal Year
20 1996; and

22 **WHEREAS,** the Cultural Preservation Committee recommends to the Legislative
23 Council approval of a consultant contract with Graciela Barajas
24 Robinson for Fiscal Year 1996 under which the consultant will
25 advise the Committee on issues relating to the Nation's participation
26 in management of the Pinacates; advise the Committee on issues

relating to the Nation's interests arising in the portion of the historic Papagueria within Mexico involving repatriation, protection of natural, cultural and sacred sites, sustainable development and the use of natural resources, and binationality and dual citizenship for members of the Nation; provide translating and interpretive services; attend meetings relating to these issues; and research and develop a proposal, including training and environmental education, for the involvement of members of the Nation residing in Mexico in the management of the Pinacates.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Tohono O'Odham Legislative Council hereby approves a consultant contract with Graciela Barajas Robinson in the amount of \$35,000., for the fiscal year ending September 30, 1996 in the form attached hereto.
2. The Legislative Council hereby appropriates the sum of \$35,000., from the General Revenue Account, to pay the fees and expenses under the consultant contract.

15 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
16 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
17 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


