(Override Vetoed Resolution No. 95-486 (Affirming and Repealing Portions of  
Resolution 93-119))**

**RESOLUTION NO. 95-516**

**WHEREAS, during the General Session of the Tohono O'odham Legislative Council of October 9, 1995, the Tohono O'odham Legislative Council did pass Resolution No. 95-486 (Affirming and Repealing Portions of Resolution No. 93-119); and**

**WHEREAS, upon presentation of Resolution No. 95-486 to the Chairman of the Tohono O'odham Nation, he did disapprove thereof and returned it to the Council with his objections in accordance with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham Nation; and**

**WHEREAS, upon further discussion during the November 6, 1995 Legislative Session, the Vice Chairman of the Nation presented the justifications in vetoing Resolution 95-486; and**

**WHEREAS, the Tohono O'odham Legislative Council has reviewed the Chairman's objections and after consideration; again voted to pass Resolution No. 95-486.**

**NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative

Council does hereby override the Chairman's veto of two-thirds votes cast.

The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 06TH. day of NOVEMBER, 1995 at a meeting at which a quorum was present with a vote of 1,354.5 FOR; 521.5 AGAINST; -0- NOT VOTING; and (03) ABSENT, was passed by majority of at least two-thirds (2/3) [1,251.] of the votes casts as required by Section V of Article VII of the Consitution of the Tohono O'odham Nation.
