

membership roll of the Tohono O'Odham Nation in accordance
with Article V of the Enrollment Ordinance.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 6TH day of NOVEMBER, 1995 at a meeting at which a quorum was present with a vote of 1,657.5 FOR; 58.5 AGAINST; 160.0 NOT VOTING; and 2 ABSENT, pursuant to the powers vested in the Council by Section I of Article II and Section I (h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


