**LEGISLATIVE ORDER NO. 95-519**

**WHEREAS, the Enrollment Committee presented the November Enrollment Application and Relinquishment to the Tohono O'odham Legislative Council in closed session; and**

**WHEREAS, upon further discussion and concerns by the Council regarding confidentiality a motion was made to refer the issue of confidentiality to the Rules Committee for review of Resolution No. 94-469 (confidentiality) and after having been reviewed by the committee that it be presented to the Council in the December General Session.**

**NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council directs the Rules Committee to review Resolution No. 95-469 (Confidentiality) and present it to the Council in the December General Session.**

**The foregoing Order was passed by the Tohono O'Odham Legislative Council on the 06TH day of November, 1995 at a meeting at which a quorum was present with a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and (2) ABSENT, pursuant to the powers vested in the Council by Section 1(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
