

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with the Law Office of Russell C. Winston)**

RESOLUTION NO. 95-524

WHEREAS, pursuant to Legislative Council Resolutions 95-326 and 95-375, the Nation entered into an Attorney Contract, and Amendment No. 1 thereto, with the Law Office of Russell C. Winston (the "Attorneys") for the purpose of providing legal representation to protect the Nation's interests under the Indian Child Welfare Act in connection with an adoption proceeding involving an enrolled member of the Nation pending in Shelby County Tennessee Chancery Court; and

WHEREAS, the Attorney Contract expired on September 30, 1995; and

WHEREAS, continued representation is necessary to protect the Nation's interests in this proceeding; and

WHEREAS, the Attorney General has recommended an extension of the Attorney Contract for fiscal year 1996 in the amount of \$5,000.; and

WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of an Attorney Contract on such terms; and

WHEREAS, the operating budget for the Office of Attorney General for Fiscal Year 1996 has sufficient funds for a Contract in such amount.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Tohono O'Odham Legislative Council hereby approves the Attorney Contract with the Law Office of Russell C. Winston, in the form attached hereto, and authorizes and directs the execution of the Contract by the Chairman of the Nation.
2. All fees and expenses under the Attorney Contract shall be paid from the Fiscal Year 1996 operating budget for the Office of Attorney General.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 7TH day of NOVEMBER, 1995 at a meeting at which a quorum was present with a vote of 1,555.0 FOR; -0- AGAINST; 134.0 NOT VOTING; and 187.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
