RESOLUTION NO. 95-526

WHEREAS, by Resolutions 94-452 and 95-146 the Tohono O'odham Legislative Council approved an Attorney Contract, and Amendment No. 1 thereto, with the law firm of Rothstein, Donatelli, Hughes, Dahlstrom, Cron & Schoenburg (the "Attorneys") to provide legal representation with respect to certain of the Nation's gaming matters; and

WHEREAS, the Attorney Contract expired on September 30, 1995; and

WHEREAS, continued representation regarding gaming matters is required to protect the Nation's interests; and

WHEREAS, the Attorney General has recommended an extension of the Attorney Contract for fiscal year 1996 in the amount of \$5,000; and

WHEREAS, the operating budget of the Office of Attorney General for fiscal year 1996 includes sufficient funding for the Contract; and

WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of an Attorney Contract with the Attorneys on such terms.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract with the law firm of Rothstein, Donatelli, Hughes, Dahlstrom, Cron & Schoenburg in the amount of \$5,000 for the fiscal year ending September 30, 1996 and in the form attached hereto.
2. Funding for the Attorney Contract shall be provided under the operating budget of the Office of Attorney General for fiscal year 1996.
3. The Chairman of the Nation is authorized and directed to execute the Attorney Contract.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 7TH Day of NOVEMBER, 1995 at a meeting at which a quorum was present with a vote of 1,809.0 FOR; 67.0 AGAINST; 0 NOT VOTING; and 5 ABSENT, pursuant to the powers vested in the Council by Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
