RESOLUTION NO. 95-529

**WHEREAS, the Tohono O'Odham Department of Human Services under the
Executive Office and the Legislative Branch of the Tohono
O'Odham Nation has had a long term interest in providing Long
Term Care to its members and to establish a third party billing
system for services provided; and**

**WHEREAS, the State of Arizona Health Care Cost Containment System's
(AHCCCS) Director and the Arizona Long Term Care Services
(ALTCS) Coordinator has provided an Intergovernmental Agreement
format and conducted an orientation session and assisted in the
development of a six month transition plan; and**

**WHEREAS, it was recognized that a Start-Up Budget was needed to begin the
Program, and the Department of Human Services staff developed
an eight (8) month budget in the amount of \$131,552.00 for Case
Management and Support Costs.**

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Executive
Office, through the Department of Human Services and Legislative
Council, enter into an Intergovernmental Agreement (IGA) with the
State of Arizona Department of Long Term Care Service, with a
six(6) month transition plan and an eight (8) month start up budget
of \$131,552.

BE IT FURTHER RESOLVED that any amendments affecting the funding or
funding levels of the contract shall be submitted for review and
approval by the Tohono O'Odham Executive Office and the
Legislative Council.

BE IT FURTHER RESOLVED that the Legislative Council does hereby approve and
appropriate \$131,552.00 from the General Revenue Account.

BE IT FINALLY RESOLVED that the Nation's Chairman may enter into all
contracts required to execute the intent of this budget.


