**WHEREAS, the Tohono O'Odham Nation is presently operating the Early Childhood Head Start Program funded by the Department of Health and Human Services, Tohono O'Odham Nation, Child and Adult Care Food Program and Title XX; and**

**WHEREAS, the Nation has been informed of its Salary Adjustment for the Early Childhood HeadStart Program/Title VII in the total amount of \$35,939.97; and**

**WHEREAS, any amendments affecting the funding or funding levels of the Salary Adjustments Budget shall be submitted for review and approval by the Tohono O'Odham Legislative Council.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby approve the Salary Adjustment to the Early Childhood HeadStart Program/Title VII and authorizes expenditures in accordance with the attached budget.**
