4 **WHEREAS,** the Legislative Council of the Tohono O'Odham Nation is authorized  
5 by the Tohono O'Odham Constitution Article VI, Section 1(d)(2) to  
6 appropriate and authorize the expenditure of funds; and

8 **WHEREAS,** the Accounting Department through their analysis and in  
9 consultation with the Executive Department and the Budget &  
10 Finance Committee, have determined that it is necessary to provide  
11 additional funding and hiring new positions; and

14 **WHEREAS,** the Accounting Department has developed a plan to provide  
15 accurate and accountable fiscal information on financial records to  
16 all branches of the government, departments, districts and  
17 programs; and

21 **WHEREAS,** the Legislative Council of the Tohono O'Odham Nation passed  
22 Resolution No. 95-478 approving the FY 1996 Executive Budget  
23 which provided funding to the Accounting Department and Property  
24 and Supply.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Legislative Council approves the  
28 budget amendment to provide additional appropriation of \$432,050.,

10 **BE IT FINALLY RESOLVED** that Capital Equipment request in the amount of  
11 \$54,800., will be funded from the Executive Branch Capital  
12 Equipment Budget.

15 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council  
16 on the 9TH day of NOVEMBER, 1995 at a meeting at which a quorum was  
17 present with a vote of 1,808.5 FOR; -0- AGAINST; 67.5 NOT VOTING; and 03  
18 ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of  
19 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
20 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting  
21 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
22 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
