WHEREAS, The Legislative Council approval is requested for appropriation of funds in the amount of \$75,883.00 to operate the Tohono O'odham Rodeo and Fair for Fiscal Year 1996.

NOW, THEREFORE BE IT RESOLVED by the Legislative Council of the Tohono O'odham Naation that it appropriates funds in the amount of \$75,883.00 for the period of October 1, 1995 to September 30, 1996.

BE IT FURTHER RESOLVED that the attached budget is hereby approved and expenditures will be authorized in accordance t bo the attached budget.

Day of **NOVEMBER, 1995 at a meeting at which a quorum was present with a vote of **1,578.0 FOR; 0 AGAINST; 298.0 NOT VOTING ; and [3] ABSENT**, pursuant to the powers vested in the Council by Section **2(a)** of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
