

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Override Vetoed Resolution No. 95-534, Approving a lease of land to the Tohono**  
**O'odham Gaming Authority)**

**RESOLUTION NO. 95-551**

**WHEREAS,** during the General Session of the Tohono O'odham Legislative Council of November 8, 1995, the Tohono O'odham Legislative Council did pass Resolution No. 95-534 (Approving a lease of land to the Tohono O'odham Gaming Authority); and

**WHEREAS,** upon presentation of Resolution No. 95-534 to the Chairman of the Tohono O'odham Nation, he did disapprove thereof and returned it to the Council with his objections in accordance with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham Nation; and

**WHEREAS,** upon further discussion of the vetoed resolution during the December 4, 1995 Legislative Session, the Chairman of the Nation presented the justifications in vetoing Resolution 95-534 (a copy of which hereto attached); and

**WHEREAS,** the Tohono O'odham Legislative Council has reviewed the Chairman's objections and after consideration; again voted to pass Resolution No. 95-486.

**NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative


**Council does hereby override the Chairman's veto of two-thirds votes cast.**

The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 04TH day of DECEMBER, 1995 at a meeting at which a quorum was present with a vote of 711.0 FOR; 1,165.0 AGAINST; -0- NOT VOTING; and (01) ABSENT, failed to pass because it did not receive a two-thirds (2/3) [1,251.] of the votes casts as required by Section V of Article VII of the Consitution of the Tohono O'odham Nation.
