**WHEREAS, The Tohono O'odham Legislative Council approved Resolution 95-534 (Approving a lease of land to the Tohono O'odham Gaming Authority), where said resolution was vetoed by the Chairman of the Nation; and**

**WHEREAS, members of the San Xavier District Council addressed their concerns of not being provided the opportunity to participate in the selection of a second casino site within the San Xavier District and subsequently, the override of vetoed resolution was defeated; and**

**WHEREAS, in further discussion, other districts expressed an interest in being considered for a potential site of the second casino location, and**

**WHEREAS, the Tohono O'odham Legislative Council agreed to proceed to have the other Districts of the Nation be considered as a selection site for a second casino.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby authorizes the Tohono O'odham Gaming**
