9 determination in writing regarding each of the foregoing
10 applications for enrollment in accordance with Section 3 (c) of
11 Article III of the Enrollment Ordinance; give notice of this
12 Council's determination in accordance with Section 4 of Article III
13 of the Enrollment Ordinance; and place the names of each
14 applicant upon the membership roll of the Tohono O'Odham
15 Nation in accordance with Article V of the Enrollment Ordinance.

19 The foregoing Resolution was passed by the Tohono O'Odham Council on the
20 4TH day of DECEMBER, 1995 at a meeting at which a quorum was present
21 with a vote of 1,876.0 FOR; 0 AGAINST; 0 NOT VOTING; and 2 ABSENT,
22 pursuant to the powers vested in the Council by Section 1 of Article II and
23 Section 1 (h) of Article VI of the Constitution of the Tohono O'Odham Nation,
24 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved
25 by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
26 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
27 984).
