

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving An Intergovernmental Agreement with the Town of Florence)**

3 **WHEREAS,** members of the Tohono O'odham Nation and Florence Village have

5 historically and exclusively used a portion of the Florence Cemetery
6
7 at the Florence Memorial Park, (the "Cemetery") known as Block
8
9 29, for burial purposes with the concurrence of the Town of
10
11 Florence; and

13 **WHEREAS,** the Gu Achi District, on August 20, 1994, by Resolution No. 0494-
14
15 83B, requested the Tohono O'odham Nation to enter into an
16
17 Intergovernmental Agreement with the Town of Florence to ensure
18
19 the future use of the Cemetery by Tohono O'odham members and
20
21 other persons determined by the Nation as eligible; and

23 **WHEREAS,** representatives of the Nation, have met with officials of the Town
24
25 of Florence and reached general terms for the continued exclusive
26
27 use of Block 29 by persons determined eligible by the Nation; and

WHEREAS, the Gu Achi District, on November 11, 1995, by Resolution, supports
this Intergovernmental Agreement with the Town of Florence, a
copy of which is hereto attached; and

WHEREAS, the Domestic Affairs Committee of the Legislative Council has reviewed this Agreement and recommends approval.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 1. The Intergovernmental Agreement with the Town of Florence is approved in the form attached hereto.**
- 2. The Chairman of the Nation is authorized and directed to sign the Agreement on behalf of the Nation.**
- 3. Any proposed termination of the Agreement initiated by the Nation or modification of the Agreement shall require the prior approval of the Legislative Council.**

The foregoing Resolution was passed by the Tohono O'Odham Council on the 06TH, day of DECEMBER, 1995 at a meeting at which a quorum was present with a vote of 1,771.0 FOR; -0- AGAINST; -0- NOT VOTING; and 105.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 3 Article VI Section 1(f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
