WHEREAS, the Tohono O'odham Nation is presently operating the Office of the Executive Director Program under FY 1996 P.L. 93-638 contract with the Indian Health Services; and

WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'odham legislative Council; and

WHEREAS, an amendment has been submitted for review and approval by the office of the Executive Director Program.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the amendment to the Office of the Executive Director Program contract and authorizes expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to

11 Article VI Section 1(d) of the Constitution of the Tohono O'Odham Nation,
12 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
13 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


