

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Extension of Interim Gaming Device Fee Payment to the State)**

RESOLUTION NO. 95-582

WHEREAS, by Resolution No. 95-383, the Tohono O'odham Legislative Council authorized payment of an interim Gaming Device Assessment fee of two hundred and fifty-eight (\$258) per gaming device, per annum; and

WHEREAS, the interim rate payment was authorized for the period covering July 1995 through December 1995, pending renegotiation of a new Gaming Device Assessment fee; and

WHEREAS, negotiations between the Arizona Department of Gaming and representatives of the Nation for the purpose of determining a new Gaming Device Assessment fee have not commenced; and

WHEREAS, the Nation has made all payments to the State in accordance with Resolution No. 95-383; and

WHEREAS, it is in the Nation's interests to continue payments of the interim Gaming Device Assessment fee pending negotiation of, and agreement to a new fee rate.

NOW, THEREFORE, BE IT RESOLVED that the Interim Gaming Device Assessment fee authorized under Resolution No. 95-383 in the amount of thirty

two thousand two hundred and fifty dollars (\$32,250) per quarter,
is hereby extended for the period covering January 1, 1996 through
June 30, 1996, pending agreement on, and Legislative Council
approval of, a new fee rate.

12 pursuant to the powers vested in the Council by Section 3 of Article II and
13 Article VI Section 1(f) of the Constitution of the Tohono O'Odham Nation,
14 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
15 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
