**WHEREAS, the Tohono O'odham Nation has received a contract from the  
Arizona Department of Health Services for Human  
Immunodeficiency Virus Prevention and Control Services in the  
amount of \$11,250.00; and**

**WHEREAS, the Tohono O'odham Nation does desire to contract with the  
Arizona Department of Health Services to provide community  
education, information and prevention services during FY 1996; and**

**WHEREAS, the Tohono O'odham Legislative Council has reviewed and approved  
the FY 1996 Community Counseling and Relations Services Program  
Scopes of Work and Budget.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council does hereby authorize to contract with the Arizona  
Department of Health Services for provision of services titled:  
Community Counseling and Relations Services.**

**BE IT FURTHER RESOLVED that the duration of this contract shall commence  
on October 01, 1995 through December 30, 1997; and**

**BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the

Tohono O'odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed contract has been awarded by the Arizona Department of Health Services, unless the agency authorizes pre-award costs.

**BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the

Tohono O'odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.


The foregoing Resolution was passed by the Tohono O'Odham Council on the 08TH. day of DECEMBER, 1995 at a meeting at which a quorum was present with a vote of 1,716.0 FOR; -0- AGAINST; -0- NOT VOTING; and 160.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 3 of Article II and Article VI Section 1(f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
