

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Establishment of Operating Accounts at Bank of America, Arizona)**

**RESOLUTION NO. 95-595**

**WHEREAS, by resolution 95-113, the Tohono O'odham Legislative Council authorized the Budget and Finance Committee and Investment Committee (Collectively the "Committees") to establish accounts at Bank of America Arizona ("Bank of America"); and**

**WHEREAS, by resolution 95-590, the Tohono O'odham Legislative Council authorized the transfer of all accounts held by Sutro & Company and the Nation's other investment accounts; and**

**WHEREAS, the Committees also recommended that the Nation use Bank of America to act as the Nation's Commercial banker with regard to all cash accounts used for the receipt and disbursement of the Nation's revenues and expenditures (the "operational accounts").**

**NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby authorizes the Budget and Finance Committee and Chief Financial Officer to establish the operational accounts with Bank of America to transact the Nation's Banking business.**

**BE IT FINALLY RESOLVED upon the establishment of operational accounts at Bank of America, Arizona and after such time that all outstanding**

11 Article VI Section 1(d)(2) of the Constitution of the Tohono O'Odham Nation,  
12 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by  
13 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
