WHEREAS, the Tohono O'odham Nation has operated successfully an Early Childhood Headstart and Day Care Program for its young members; and

WHEREAS, the Arizona Department of Education through a Child Adult Care Food Services which provides reimbursement of funds for food costs incurred based on the guidelines identified in the contract; and

WHEREAS, the Early Childhood, Headstart Day Care Program submits for review and approval of the Child Adult Care Food Program Contract for Fiscal Year 1996.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves and authorizes the participation of the Tohono O'odham Nation Early Childhood Headstart Day Care Program in the Child Adult Care Food Program.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the duration of the agreement shall commence on October 01, 1995 through September 30, 1996.
