funding directly from the Tohono O'odham Nation; and**

**WHEREAS, the program's current mode of operation requires modification to
the approved budget (due to an increase in the number of
meetings required to oversee the planning process, the need to hire
a Nursing Home Project Educational Coordinator and expenses
associated with a new telephone system); and**

**WHEREAS, the Nursing Home Project has submitted a budget modification for
approval by the Legislative Council of the Tohono O'odham Nation
with the request for reallocation of funds within the existing budget
of \$206,210.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
that it approves Modification #1 to the Nursing Home FY 1996
Operating Budget which reallocates funds within the existing budget
of \$206,210.**


