**WHEREAS, the Tohono O'Odham Nation is presently operating the
Psychological Services under FY 1996 P.L. 93-638 contract
with the Public Health, Indian Health Services; and**

**WHEREAS, the Tohono O'Odham Legislative Council has reviewed and
approved the FY 1996 Indirect Cost Rate of 17%.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
Legislative Council does authorize and request the Public
Health, Indian Health Service to contract with the Tohono
O'Odham Nation under P.L. 93-638 as amended for
provision of services titled: Division of Psychological
Services.**

**BE IT FURTHER RESOLVED that the duration of this renewal shall
commence on October 1, 1995 through September 30,
1996; and**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative
Council that the Tohono O'Odham Nation will not fund or
operate the program in the interim while negotiations still
being conducted and no executed contract has been
awarded by the Indian Health Service, unless the agency
authorizes and approves pre-award costs consistent with**
