8 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed and**
9 **approved the FY 1996 Indirect Cost Rate of 17%.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham**
12 **Legislative Council does authorize and request the Public**
13 **Health, Indian Health Service to contract with the Tohono**
14 **O'Odham Nation under P.L. 93-638 as amended for**
15 **provision of services titled: Division of Psychological**
16 **Services/Children's Initiative Component.**

19 **BE IT FURTHER RESOLVED that the duration of this renewal shall**
20 **commence on October 1, 1995 through September 30,**

23 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative**

25 **the program in the interim while negotiations still being**
26 **conducted and no executed contract has been awarded by**
