**WHEREAS, the Tohono O'odham Legislative Council approved the FY96  
Legislative Branch Budget by Resolution No. 95-404; and**

**WHEREAS, on January 9, 1996 the Budget & Finance Committee reviewed and  
approved the Legislative FY96 Budget to move program monies to  
the salary line item and other line items; and**

**WHEREAS, the Budget & Finance recommends the approval of the FY 1996  
Legislative Branch Budget Amendment.**

**NOW, THEREFORE, BEFORE IT RESOLVED that the Tohono O'odham Legislative  
Council hereby approves the 1996 Legislative Branch Budget  
Amendment No. 1.**

**The foregoing Resolution was passed by the Tohono O'Odham Council on the  
10TH. day of JANUARY, 1996 at a meeting at which a quorum was present with  
a vote of 1,716.0 FOR; -0- AGAINST; -0- NOT VOTING; and 160.0 [03] ABSENT,  
pursuant to the powers vested in the Council by Article VI Section 1(d) of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
of the Act of June 18, 1934 (48 Stat. 984).**
