**RESOLUTION NO. 96-029**

**WHEREAS,** the Tohono O'odham Legislative Council did approve phase one of  
the 1996 accounting plan; and

**WHEREAS,** Phase one of the 1996 accounting plan included funds for new  
office furniture; and

**WHEREAS,** the resolution approving phase one indicated that funds for the  
furniture and equipment would come from the Nation's capital  
budget; and

**WHEREAS,** the Nation's capital budget has been fully allocated for other needs;  
and

**WHEREAS,** savings exist in the Accounting Department Budget.

**NOW, THEREFORE, BEFORE IT RESOLVED that:**

1. The Legislative Council approves the creation of a new line item  
in the Accounting Budget -- 752 Office and Communication  
Budget.

2. The Legislative Council approves the accounting budget  
modification transferring \$49,818.18 from Salaries and \$4,981.82  
from Fringe Benefits to Office and Communication Equipment.
