O'odham Legislative Council regarding the Economic Development
funds that was allocated to the eleven (11) districts for Economic
Development purposes; and

WHEREAS, the HICKIWAN DISTRICT COUNCIL is requesting approval from the
Tohono O'odham Legislative Council to utilize the Economic
Development funds; and

WHEREAS, this would allow HICKIWAN DISTRICT to have available the Economic
Development Funds to help fund some of the costs associated with
the proposed Casino, Convenience Store and RV Park Project; and

WHEREAS, the \$100,000.00 Economic Development Funds are in the Bank One
- Ajo Branch Office and will be in a checking account for HICKIWAN
District to utilize in the Economic Development Project.

NOW, THEREFORE, BEFORE IT RESOLVED by the Tohono O'odham Legislative
Council that it hereby approves the request from the HICKIWAN
District to utilize the Economic Development Funds that was
allocated to the Districts.




