**RESOLUTION NO. 96-042**

**WHEREAS, the Tohono O'odham Nation is presently operating the Elderly Title III C-1 Program under an agreement with Inter-Tribal Council of Arizona for the benefit of its elder members of the Nation; and**

**WHEREAS, any amendments affecting the funding level of the Agreement with Inter-Tribal Council of Arizona shall be submitted for review and approval by the Tohono O'odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval by the Tohono O'odham Senior Services.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the amendment and authorizes expenditures in accordance with the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's officials to wit: the Chairman and Vice Chairman are hereby authorized to negotiate and execute the agreement, provided however, that any amendments affecting the funding or funding levels of the agreement shall be submitted for further prior approval by this Council.**
