RESOLUTION NO. 96-043

WHEREAS, the Division of Senior Services under the Tohono O'odham Nation
operates the elderly nutrition/transportation program; and

WHEREAS, there is only one operational handicap accessible van available and
four of the program vans have over 100,000 miles; and

WHEREAS, the Division of Senior Services has submitted an application to Pima
Association of Governments requesting a "cutaway" handicap
accessible van and a 14 passenger van to be awarded by the
Arizona Department of Transportation; and

WHEREAS, the Arizona Department of Transportation requires the assurance of
a 22.5% match by the Nation which amounts to \$15,075.00 at the
time the vans are awarded in 1997; and

WHEREAS, the Tohono O'odham Executive Office, through the Department of
Human Services and the Legislative Council has signed a letter of
assurance to the Pima Association of Governments and the Arizona
Department of Transportation that the Nation will match funds of
22.5% for the purchase of two vans.

NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby
approve and appropriate \$15,075.00 from the Fiscal Year 1997
Executive Budget for Capital Expenditures for the Tribal match
funds for two vans for the Senior Services Elderly program.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 6TH. day of FEBRUARY, 1996 at a meeting at which a quorum was present with a vote of 1,716.0 FOR; -0- AGAINST; -0- NOT VOTING; and 160.0 [07] ABSENT, pursuant to the powers vested in the Council by Article VI Section 1(d)(2) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


