**WHEREAS, the Tohono O'odham Nation is currently operating the Tohono  
O'odham Senior Services program with Tribal Funds; and**

**WHEREAS, amendments affecting the funding level or change in the purpose  
for which the funds were budgeted are required to be submitted  
for review and approval by the Tohono O'odham Legislative  
Council; and**

**WHEREAS, an amendment has been submitted for review and approval.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
Council that it hereby approves this amendment and authorizes  
expenditures in accordance with the attached budget modification.**


**The foregoing Resolution was passed by the Tohono O'Odham Council on the  
7TH. day of FEBRUARY, 1996 at a meeting at which a quorum was present with  
a vote of 1,759.0 FOR; -0- AGAINST; -0- NOT VOTING; and 117.0 [06] ABSENT,  
pursuant to the powers vested in the Council by Article VI Section 1(d)(3) of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
of the Act of June 18, 1934 (48 Stat. 984).**
