**WHEREAS, the Bank of America has offered the Tohono O'odham Nation the  
sum of \$15,000 for the benefit of the 1996 Rodeo and Fair; and**

**WHEREAS, the Tohono O'odham Nation is appreciative of the generous gift  
made by the Bank of America to the Nation.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council accepts on behalf of the Nation, the sum of \$15,000 from  
the Bank of America for the benefit of the 1996 Tohono O'odham  
Rodeo and Fair.**

**BE IT FURTHER RESOLVED that the budget is hereby approved and that  
expenditures will be authorized in accordance to the attached  
budget.**

**The foregoing Resolution was passed by the Tohono O'Odham Council on the  
9TH. day of FEBRUARY, 1996 at a meeting at which a quorum was present with  
a vote of 1,759.0 FOR; -0- AGAINST; -0- NOT VOTING; and 117.0 [08] ABSENT,  
pursuant to the powers vested in the Council by Article VI Section 1(d)(2) of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
of the Act of June 18, 1934 (48 Stat. 984).**
