

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Revisions to FY 1996 Projected Revenues)

RESOLUTION NO. 96-072

WHEREAS, the Tohono O'odham Legislative Council did by Resolution No. 95-403 approve the FY 1996 Projected Revenues at \$16,006,000; and

WHEREAS, the Budget & Finance Committee is empowered to review and recommend measures or actions to the Tohono O'odham Legislative Council regarding appropriating for expenditure of funds; and

WHEREAS, review of the current level of appropriations by the Tohono O'odham Legislative Council necessitates revision of the FY'96 Revenue Projection.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the attached revised FY'96 Projected Revenues to be increased by \$5,847,810 for a revised total of \$21,853,810.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 29TH. day of FEBRUARY, 1996 at a meeting at which a quorum was present with a vote of 1,240.5 FOR; -0- AGAINST; 635.5 NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article VI Section 1(d) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
