

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono O'odham Nation that it approves the FY'95 Carry-Over budget of the Law Enforcement Department in the amount of \$374,110.72 and Appropriates Tribal Funds in the amount of \$1,691,108.28 for the Tohono O'odham Law Enforcement Department.**

**The foregoing Resolution was passed by the Tohono O'Odham Council on the 29TH day of FEBRUARY, 1996 at a meeting at which a quorum was present with a vote 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article VI Section 1(d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
