21 a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT,  
22 pursuant to the powers vested in the Council by Section 1 of Article II and  
23 Section 1(h) of Article VI of the Constitution of the Tohono O'Odham Nation,  
24 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by  
25 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
26 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
