O'odham Psychological Services Tas Tonlik Day Program through  
P.L. 93-638 grant with the Department of Health & Human Services;  
and**

**WHEREAS, any amendments affecting the funding or funding levels of the grant  
shall be submitted for review and approval by the Legislative  
Council; and**

**WHEREAS, FY 95 Carry-over funds in the amount of \$125,958.00 is reflected;  
and**

**WHEREAS, the Tas Tonlik Ki Day Program for the seriously and persistently  
mentally ill have been effective means of providing psychosocial  
rehabilitation services; and**

**WHEREAS, the Department of Human Services TOPS/SMI Program has prepared  
and submitted a budget modification for review and approval.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council does hereby approve and authorize expenditures in**

execute the grant provided however, that any amendments affecting  
the funding or funding levels of the grant shall be submitted for  
further prior approval by this Council.

day of MARCH, 1996 at a meeting at which a quorum was present with a vote  
1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the  
powers vested in the Council by Article VI Section 1(f) of the Constitution of the  
Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,  
1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
(48 Stat. 984).
