RESOLUTION NO. 96-092

WHEREAS, the Tohono O'odham Social Service Department has the primary responsibility to provide prevention and intervention services to families at risk for child abuse and neglect; and

WHEREAS, the Arizona Department of Economic Security provides funds for the development and administration of child abuse and neglect prevention programs under specified terms and conditions; and

WHEREAS, Parent Training has been identified as one means of preventing child abuse and neglect; and

WHEREAS, the Tohono O'odham Social Service Department has submitted an FY 1997 proposal for Parenting Skills for review and approval.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the application of the Tohono O'odham Social Service for a contract to focus on decreasing the incidence of child abuse and neglect through the provision of parent effectiveness training and child development education reservation wide.
