**WHEREAS,** the budget proposed is to include a new line item for a leased vehicle for the O'odham in Mexico program; and

**WHEREAS,** the program did not include the lease under the FY96 program budget due to being funded under the Executive Offices' Capital Budget line item; and

**WHEREAS,** the Executive Assistant was present to address the balance and obligated funding for other programs under the Capital Equipment line item; and

**WHEREAS,** upon further discussion, the Executive Office stated that there are no remaining funds available to lease the remainder of the O'odham in Mexico's program vehicle due to obligated funding to other programs; and

**WHEREAS,** concerns regarding the budget of the Executive Offices' Capital Equipment line item need to be reviewed.

BE IT FURTHER RESOLVED that the review of the identified savings be readdressed in the March 8, 1996 General Session.


