4 **WHEREAS,** the Tohono O'odham Nation ("Nation") suffers from a number of  
5 illnesses and diseases including, but not limited to alcoholism,  
6 diabetes mellitus, Human Immunodeficiency Virus (HIV)/Acquired  
7 Immunodeficiency Disease Syndrome (AIDS), tuberculosis and a lack  
8 of emergency medical services and basic transportation; and

11 **WHEREAS,** the Nation, through the Department of Human Services offers  
12 programs concerned with the delivery of services which addresses  
13 the illnesses and diseases afflicting the Nation; and

16 **WHEREAS,** present staffing and funding for delivery of such services is  
17 inadequate to meet the high demand of patients and clients  
18 suffering from these conditions and the continuing rise in the  
19 number of patients and clients needing services; and

22 **WHEREAS,** Indian Health Services (IHS) has been directed to implement FTE  
23 ceiling and administrative budget cuts which further impacts on  
24 already inadequate staffing and resources to fully meet the demand  
25 and rise in the incidence of the nation's illness and disease; and

28 **WHEREAS,** it is the desire of the Nation to address the many health needs of

**NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council

that it does hereby urgently request that Congress appropriate

\$27,176,074 in accordance with the attached proposals to assist the

Nation in meeting the rise and demand for health services.

**BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the


appropriate officers of the Nation are hereby authorized and

directed to bring this request to the appropriate members and

committees of Congress.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 7TH day of MARCH, 1996 at a meeting at which a quorum was present with a vote 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI Section 1(j) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
