4 **WHEREAS,** at a San Lucy District Council meeting on February 28, 1996, a  
5  
6 presentation was made by Mr. Richard Smith a Junior High teacher  
7  
8 at Gila Bend School, in regards to a venture and Educational trip to  
9  
10 Washington, D.C. in June 1996 through Student Travel Agency; and

11 **WHEREAS,** three (3) San Lucy District student members were interested and  
12  
13 selected to participate in the trip. The cost for this trip per student  
14  
15 is \$895.00; and

16 **WHEREAS,** the San Lucy District Council recommends that a District Community  
17  
18 parent attend along with the students as a chaperon and the cost for  
19  
20 the adult to attend is \$970.00; and

21 **WHEREAS,** the San Lucy District seize the once in a lifetime chance for these  
22  
23 three (3) District student members to participate in this opportunity,  
24  
25 the overall Gila Bend students have been involved in fund raising  
26  
27 activities, since December 1995. As the deadline is April 1, 1996.

28 **WHEREAS,** the San Lucy District Council by majority consensus submit this  
request to the Tohono O'odham Nation's Legislative body for any

5 \$3,655.00.

6 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Nation Legislative  
7  
8 Council does support and assist the San Lucy District Council and  
9  
10 Gila Bend School trip to Washington, D.C., in the amount of  
11  
12 \$3,655.00. This sum will be withdrawn from the Tohono O'odham  
13  
14 Nation's general account.

15 The foregoing Resolution was passed by the Tohono O'Odham Council on the 7TH  
16 day of MARCH, 1996 at a meeting at which a quorum was present with a vote  
17 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the  
18 powers vested in the Council by Article VI Section 1(d)(2) of the Constitution of  
19 the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January  
20 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
(48 Stat. 984).
