(Baboquivari District FY-96 Budget Amendment)**

RESOLUTION NO. 96-139

WHEREAS, Resolution 95-466 of the Tohono O'odham Legislative Council approved Baboquivari District's budget for FY 1996; and

WHEREAS, any amendments affecting the funding level or change in the purpose for which the funds were budgeted are required to be submitted for review and approval by the Tohono O'odham Legislative Council; and

WHEREAS, Fresnal Canyon Village of Baboquivari District is in need of amending budget line item Salaries to create new line items 614 Casual Labor and 852 Donations.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the amendment to Baboquivari District /Fresnal Canyon Village FY 1996 Budget in the amount of \$5,200.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 10TH. day of APRIL, 1996 at a meeting at which a quorum was present with a vote 1,742.0 FOR; -0- AGAINST; -0- NOT VOTING; and 134.0 [07] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
