(Tohono O'odham Nation Scholarship Fund FY 1996 Budget Modification #1)**

**RESOLUTION NO. 96-141**

**WHEREAS, the Tohono O'odham Nation Scholarship Fund has brought forth a budget modification #1 to its 1995-96 tribal budget; and**

**WHEREAS, the budget modification moves savings from its Salaries, Fringe Benefits, Mileage, Gas, Oil & Coolants, Subscriptions, Repair - HVAC, and Alterations and applies them towards Office Supplies, Capital Equipment, and Repair - Vehicle; and**

**WHEREAS, the budget modification #1 will include an additional Education Assistance Counselor position and an increase in the Capital Equipment line item due to higher than expected bids for the modular building.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does support, recognize and authorize the Tohono O'odham Nation Scholarship Fund's request for the moving of savings to aforementioned line items.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it approves the Tohono O'odham Nation Scholarship Fund's budget modification #1.**


