**WHEREAS, the Tohono O'odham Legislative Council is desirous of continuing this
program for the benefit of its young members.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
that it does hereby approve the proposed Budget for FY 1997 Title
XX - Child Day Care Services.**

**BE IT FURTHER RESOLVED that the duration of the Budget will be from July
01, 1996 through June 30, 1997.**

the contract, provided however, that any amendments affecting the
funding or funding levels of this contract shall be submitted for
further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Council on the
10TH. day of APRIL, 1996 at a meeting at which a quorum was present with a
vote 1,582.0 FOR; -0- AGAINST; -0- NOT VOTING; and 294.0 [07] ABSENT,
pursuant to the powers vested in the Council by Article VI, Section 1(f) of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
of the Act of June 18, 1934 (48 Stat. 984).
