RESOLUTION NO. 96-149

WHEREAS, the Tohono O'odham Nation is currently operating the Hia-Ced O'odham Program with tribal funds; and

WHEREAS, modifications affecting the change in the purpose for which funds were budgeted are required to be submitted for review and approval by the Tohono O'odham Legislative Council; and

WHEREAS, a budget modification has been submitted for review and approval.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves this modification in accordance with the attached budget.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 10TH. day of APRIL, 1996 at a meeting at which a quorum was present with a vote 1,742.0 FOR; -0- AGAINST; -0- NOT VOTING; and 134.0 [07] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
