RESOLUTION NO. 96-153

WHEREAS, the Gu Achi District has reviewed and considered to amend its FY 95-96 Budget; and

WHEREAS, the Gu Achi District FY 95-96 Budget was \$448,723.89 and it will be amended by \$40,500.00, for a total budget of \$489,223.89; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed the proposed budget amendment and approve the same.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the Gu Achi District Council budget amendment to be expended in accordance with the attached budget.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 11TH day of APRIL, 1996 at a meeting at which a quorum was present with a vote 1,485.0 FOR; -0- AGAINST; -0- NOT VOTING; and 391.0 [08] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
