4 **WHEREAS,** the Tohono O'odham Nation is presently operating the Family and

6 Children's Service Unit of the Tohono O'odham Department of

8 Human Services, Division of Child Welfare Services under FY 1996
9
10 P.L. 93-638 contract with the Bureau of Indian Affairs; and

11 **WHEREAS,** Child Welfare Services caseload has increased tremendously and
12
13 there has not been enough funding to meet these needs; and

14 **WHEREAS,** Project 2000 is a 5 year phase plan to increase funding for
15
16 additional staff to address the increased need for child welfare
17
18 services; and

19 **WHEREAS,** in reviews, both Executive and the Legislative Oversight Committees

21 recommend approval of Phase I budget and will address each phase
22
23 annually as funds are available.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative

26 Council does hereby approve the Tohono O'odham Nation Base

28 Budget for Family and Children's Services - Project 2000 Phase I in
the amount of \$63,923.00 for 6 months until the end of FY 1996.



16 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**


